Hello Everyone,

It is hard to believe that we are coming up on the one-year mark of our response to COVID-19. I'm sure many of you have read a lot of headlines about this anniversary, as North Carolina saw its first documented case in early March.

Thankfully, now a year later, we have received uplifting news this week with the rollout of the Johnson & Johnson vaccine. Additionally new partnerships at the federal level are said to be increasing the number of vaccine doses. We've been told that production levels should allow enough vaccines for every adult by the end of May. That is a much quicker timeline than we heard just weeks ago.

It feels like we are heading in the right direction but we should remember to remain vigilant until we achieve herd immunity. Practice the three Ws, and stay safe!

Ask the Manager

Our first question in this new feature comes from Sharon from Chapel Hill Public Library. She asks: "Can you give us any guidance as to which employees fit under the Group 3 'government and community services' umbrella?"

A very good, timely question. Thank you, Sharon.

Group 3 is made up of "frontline essential workers" such as teachers, grocery workers, restaurant workers, postal employees, police officers, firefighters, and bus drivers, and perform an essential task that is **public** facing or have close contact with <u>other people</u> and have to leave home to work.

Anyone outside of your household germ bubble counts as "other people." And indoors always raises the risk of transmission.

If you work in one of the groups below <u>and</u> your employer requires you to work in person (not remotely) <u>and</u> you have close contact with other people, you are a frontline essential worker. Close contact is defined as being closer than six feet for longer than 15 minutes over a 24-hour period.

New State Executive Order

Governor Roy Cooper announced last week the signing of Executive Order No. 195, effective Feb. 26. This order loosened some restrictions, including lifting the modified stay-at-home order (meaning no more curfew), raising the indoor gathering limit to 25 people (still masked and physically distant), and increasing capacity for some businesses.
